

# **BROOMIEKNOWE GOLF CLUB LTD**

## **DISCIPLINARY PROCEDURE (MEMBERS)**

A model disciplinary procedure for use by golf clubs has been prepared for Scottish Golf by DLA Piper Solicitors. This procedure has been adapted for Broomieknowe Golf Club.

## 1. INTERPRETATION AND DEFINITIONS

1.1 In the interpretation of these procedures, unless the contrary intention appears:

1.1.1 headings are inserted for convenience only and are not to be used to assist interpretation;

1.1.2 any gender includes all genders, any reference to the singular includes the plural (and vice versa), and references to persons includes bodies corporate, unincorporated associations and partnerships (whether or not any of them have a separate legal personality).

1.2 For the purpose of these procedures the following definitions apply:

**"Appeals Committee"** means an Appeals Committee appointed by the Club;

**"Anti Doping Policy"** means the Anti Doping Policy of the SGU;

**"Appellant"** means any member subject to a disciplinary decision who chooses to appeal it;

**"Captain"** means the Captain of the Club;

**"Club"** means Broomieknowe Golf Club Ltd;

**"Competition"** means any competition organised by the Club;

**"Complainer"** means any person making a complaint about any Member;

**"CONGU"** means the Council of National Golf Unions;

**"Council"** means the Board of Directors of the Club;

**"Day"** means any day other than a Public Holiday;

**"Director"** means any member of Council;

**"Disciplinary Committee"** means the Disciplinary Committee of the Club;

**"Member"** means any member or associate member of the club who is subject of any disciplinary investigation in accordance with these procedures;

**"Player"** means a person who plays the game of golf;

**"Procedures"** means these Procedures;

**"Rules of Golf"** means the rules of golf as defined by the Royal & Ancient Golf Club of St Andrews.

## **2. OVERVIEW**

2.1 These Procedures deal with hearings in respect of:

2.1.1 breaches of the Club's Bye-Laws, Rules of Golf, Code of Conduct, Policies and Procedures or other such rules that the Club may, from time-to-time, make;

2.1.2 any complaint about any member; and

2.1.3 complaints regarding any person competing officially in any Club competition.

2.2 The Procedures apply to all members of the Club.

2.3 Disciplinary action may be informal or formal. Informal disciplinary action will involve discussing the problem with the member and/or the complainer through the Captain or their nominated Director with a view to resolving the issue. Formal disciplinary action will be taken in accordance with these Procedures.

## **3. MEMBERSHIP AND POWERS OF COMMITTEES**

3.1 The Club shall establish a Disciplinary Committee which shall have the power to act in the name of the Club and determine disciplinary proceedings coming before it.

3.2 The membership of any Disciplinary Committee will be determined by the Club and will have not fewer than 5 members of the Council and may have one person who is legally qualified in such matters.

3.3 The Club will establish an Appeals Committee to consider any competent appeal. This Committee shall have not fewer than 3 members, consisting of Past Captains or Members with of more than 30 years full membership of the Club or serving members of Council or Members with experience in mediation and may include one

person who is legally qualified in such matters. None of these members shall be members of the Disciplinary Committee.

- 3.4 Any person who sits on either the Disciplinary Committee or Appeal Committee shall:
  - 3.4.1 be unbiased and have no personal interest in or involvement with the case;
  - 3.4.2 be familiar with these procedures;
  - 3.4.3 act within their powers under these procedures and fairly, reasonably and proportionately at all times;
  - 3.4.4 take advice where appropriate including, if necessary, appointing a solicitor or legal representative to attend and advise at hearing;
  - 3.4.5 have consideration and respect for all parties; and
  - 3.4.6 apply the standard of proof as the balance of probabilities.
- 3.5 The Appeals Committee will have the full powers and authorities of the Disciplinary Committee including the power to increase, decrease or accept any such penalties already imposed and/or impose any such new penalties as outlined in these Procedures.
- 3.6 Both the Disciplinary and Appeal Committees shall appoint a chair who will preside over each Committee.
- 3.7 Both Committees shall take decisions, including decisions as to guilt and appropriate sanctions, on the basis of a simple majority of Committee members with the Chair holding a casting vote if no majority is reached.
- 3.8 The Club may require that an appeal shall be accompanied by a deposit of £100. The Appeals Committee will decide on whether or not a deposit paid on the lodgement of an appeal, or any part of it, is refundable. However, the standard practice shall be to return the deposit in the event of a successful appeal.
- 3.9 The Disciplinary Committee and the Appeals Committee shall have the power to abridge or extend any time limits set out in these Procedures, if in their reasonable discretion, it is considered appropriate in the circumstances.

- 3.10 The Disciplinary Committee and the Appeals Committee shall not be entitled to introduce or consider opinion evidence other than expert opinion evidence.
- 3.11 The Disciplinary Committee and Appeals Committee shall exercise their functions independently of the Club.

#### **4. INITIAL COMPLAINT HANDLING**

- 4.1 Any complaints about a Member should be made in writing by the complainer and sent to the Captain or a Director and be signed and dated.
- 4.2 Any complaint must be lodged within 7 days of the alleged incident or grounds for the complaint arising or becoming known or such further time as is reasonably allowed by the Captain or their nominated Director.
- 4.3 The complaint must specify the details of the alleged incident or grounds for complaint including, if appropriate, which provision of Club Rules, Bye Laws, Code of Conduct, Club Policy etc. has been breached.
- 4.4 The Captain or their nominated Director shall:
- 4.4.1 forward a copy of the complaint to the member in question and request a written response within 7 days;
  - 4.4.2 undertake any further investigation he/she sees fit and/or;
  - 4.4.3 forward the complaint, written response and any other relevant material, if applicable, to the Disciplinary Committee for consideration as set out below.
- 4.5 Upon receiving a referral from the Captain or their nominated Director, the Chair of the Disciplinary Committee shall convene a hearing of the Disciplinary Committee.

#### **5. DISCIPLINARY HEARING**

- 5.1 Any person that is subject to a disciplinary hearing shall be supplied with a copy of the original complaint and any additional material provided to the Disciplinary Committee, including notice of any witnesses to be called or their evidence;
- 5.2 Each Member shall have the right to the following:

- 5.2.1 to be advised of the nature of the charge or complaint and the potential penalties that may apply;
- 5.2.2 to be present in person at any hearing and to be advised 14 days in advance of the date, time and place of such hearing;
- 5.2.3 to representation (legal or otherwise) at this hearing;
- 5.2.4 to state his case, call relevant witnesses and provide evidence at this hearing.
- 5.3 A shorter notice period can be given if agreed with the respective parties to the hearing.
- 5.4 Names of any witnesses being proposed by the Member should be intimated 7 days before any hearing to the Captain or their nominated Director.
- 5.5 If the Member is unable to attend at the meeting, he should notify the Captain or their nominated Director in writing.
- 5.6 If the Member elects not to attend at the meeting without good reason, the disciplinary hearing may proceed in their absence.
- 5.7 Unless the Disciplinary Committee otherwise directs the procedure will be as follows:
  - 5.7.1 the Disciplinary Committee will explain the process and advise of the rights of appeal;
  - 5.7.2 the terms of the Complaint will be considered followed by the written or oral response, if any, provided by the Member, including representation on penalty;
  - 5.7.3 any further evidence will be heard;
  - 5.7.4 any other witnesses to be called will then be heard (or in the situation where the witness is unable to attend, then their signed written statement will be read out);
  - 5.7.5 any witnesses are to be excluded from the hearing until required to give their evidence and must retire immediately after giving their evidence and answering any questions from the Disciplinary Committee;

- 5.7.6 questioning of the parties or any witnesses may only be directed by the Disciplinary Committee or as otherwise permitted by the Disciplinary Committee at its discretion, acting fairly and reasonably.
- 5.7.7 the Member will then be given the opportunity to make final submissions, including submissions on sanctions in the event that the complaint is upheld; and,
- 5.7.8 notification of the decision, including as to any sanctions, with appropriate reasons shall be issued by the Captain or their nominated Director, in writing, to the parties within 14 days of the hearing.

## **6. APPEAL HEARING**

- 6.1 An appeal must be lodged within 14 days of the decision being notified in writing to the Member.
- 6.2 An appeal shall be lodged when a Notice of Appeal is received, accompanied by the Appeal Fee (if appropriate), by the Captain or their nominated Director. The Notice of Appeal shall be in writing, signed by the Appellant Member and shall specify:
  - 6.2.1 the name of the Appellant Member;
  - 6.2.2 the decision appealed against;
  - 6.2.3 the date of the decision appealed against; and
  - 6.2.4 the specific grounds of the appeal (including in relation to sanctions).
- 6.3 On receipt of an appeal, the Captain or their nominated Director will automatically forward all documentation to the members of the Appeals Committee.
- 6.4 The Captain or their nominated Director shall communicate with the Appellant Member and:
  - 6.4.1 set a time, date, and place for the hearing of the appeal;
  - 6.4.2 of the composition of the Appeals Committee;
  - 6.4.3 of the rules within this Procedure which govern the hearing and process.

- 6.5 The Appellant Member is entitled to, within 48 hours of notification, lodge a written objection against any member of the Appeals Committee who can be shown to have a direct personal involvement or interest in the matter. Supporting evidence should be provided in support of any such claim. Any objection will be considered by the Captain or their nominated Director, whose decision shall be final.
- 6.6 All documentation to be used by any party at the appeal must be with all of the parties entitled to attend the appeal hearing at least 7 days prior to the appeal hearing.
- 6.7 The Appeals Committee will, in advance of and in preparation for the Appeal Hearing, consider the evidence set before the Disciplinary Committee. This evidence will not be re-heard in its entirety at an Appeal Hearing
- 6.8 The Appeals Committee shall be entitled to hear and receive such further evidence on appeal as it deems competent and fair.
- 6.9 Any further evidence to be heard, shall be made available to the Appellant member 7 days prior to the appeal hearing. Parties shall have the right to respond in writing to any further evidence to be presented.
- 6.10 Where evidence is given before the Appeals Committee, there shall only be cross examination or questioning of witnesses by the Appeals Committee.
- 6.11 Written notification of the decision of the Appeals Committee will be issued to the Appellant member within 14 days stating full reasons for the decision.
- 6.12 The decision of the Appeals Committee is final and binding with no further opportunity for Appeal.

## **7. PENALTIES**

- 7.1 No penalty shall be imposed on any person or body in disciplinary proceedings unless the alleged misconduct against the person or body is proved on the balance of probabilities and that penalty is fair, reasonable and proportionate in the opinion of the Disciplinary or Appeals Committees.
- 7.2 If a complaint is proved against a Member, the Disciplinary Committee and Appeals Committee shall have the power to impose the following penalties:
- 7.2.1 reprimand/warning;

- 7.2.2 suspension from Club membership for a specified period of time (including competition);
  - 7.2.3 suspension from specified Club activities for a period of time or permanently;
  - 7.2.4 expulsion from Club membership on a permanent basis;
  - 7.2.5 forfeiture of any competition and/or other points as specified;
  - 7.2.6 penalty pursuant to Clause 24 of the CONGU Unified Handicapping System (Suspension and Loss of Handicap) and/or Rule 7c of the WHS Rules of Handicapping (Withdrawing a Handicap Index);
  - 7.2.7 a combination of any of the above.
- 7.3 When a penalty is imposed consideration will be given to the following:
- 7.3.1 consistency and uniformity in the level of penalty imposed;
  - 7.3.2 whether the penalty is reasonable and proportionate in all the circumstances; and,
  - 7.3.3 that, where possible, periods of suspension be imposed by reference to specific dates rather than playing days e.g. 1 April to 1 June.
- 7.4 Any penalties imposed by the Disciplinary Committee shall be suspended on any Notice of Appeal being received in accordance with this Policy until the outcome of the Appeal Hearing, except in the following cases where they shall be upheld pending any Appeal Hearing:
- 7.4.1 any penalty imposed under the SGU's Anti-Doping Policy;
  - 7.4.2 any penalty imposed under the SGU's Child Protection Policy.
  - 7.4.3 any penalty imposed relating to the Member's handicap or right to play golf.

## **8. GENERAL PROVISIONS**

- 8.1 The hearing of proceedings by the Disciplinary Committee or the Appeals Committee shall be recorded by the taking of minutes by the Captain, their nominated Director or another nominated and appropriate person.

- 8.2 The record of the proceedings and all papers associated with the proceedings shall be held by the Captain or their nominee in a secure and appropriate manner.
- 8.3 Copies of the record shall be made available to any person affected by the decision of the Disciplinary Committee or Appeals Committee.
- 8.4 Any notices or correspondence to be sent to any Member or person under these procedures shall be sent by recorded delivery to the last known address of that Member or person. The relevant time period shall begin on the deemed date of receipt.
